

Lafayette Band Association 2017-18 Payment Agreement for Concert and Marching Band

Please complete and sign this payment agreement to reserve your place in the 2017-18 Lafayette Concert or Marching Band. This agreement should be returned with the first month's payment by March 15, 2017. The Concert and Marching band payments for this year remain the same as last year at \$300 or \$1,100, respectively. There are 3 payment schedules for marching band available for your convenience. Sibling payments are for the second student when 2 siblings are currently in marching band. Please note that even if you do not return the Payment Agreement, your student's participation obligates you to the payment.

- \$1,000 for the Early Payment Schedule (\$100 discount)* – must be **paid in full prior to May 15, 2017.**
- \$1,100 for the Standard Payment Schedule – must be paid in full by August 15, 2017.
- \$1,250 for the Deferred Payment Schedule (includes \$150 late payment) – must be paid in full by November 15, 2017.
- \$500 for the Sibling Early Payment – must be **paid in full prior to May 15, 2017.**
- \$550 for the Sibling Standard Payment – must be paid in full by August 15, 2017. Otherwise, payment will be \$625.
- \$300 for the Concert Only Payment – must be paid in full by December 15, 2017.
- My student qualifies for the Free/Reduced Lunch Program. I understand I must contact Mr. Smith at chuck.smith@fayette.kyschools.us or 859-396-3311 by March 15, 2017 to verify and provide a copy of the Notice of Approval received from the Child Nutrition Office.
